\$500.00 has been received as a deposit for one French Bulldog puppy. (\$_____ is the total purchase price.)

1. The deposit (\$500) is non-refundable. Unless there are no puppies of the sex the deposit was placed, or no puppies are born. Upon receipt of the deposit, you will be placed on our deposit list. Your place on the deposit list is determined by the date the deposit was received. As those ahead of you pick their puppies, you will rise in picking order. You may pick from any puppy in the order listed, with the exception of the breeder keeping a puppy or the stud dog owner. (if applicable). Personal checks may be sent for the deposit, but not for the final payment. Final payment must be Cash, Casheirs Check, or Postal money order. We also accept Paypal credit card payments with a 3% surcharge

2. The puppy will be shipped by air at the buyers expense between 8 and 9 weeks. The balance of Puppy purchase price is \$_____ plus \$_____ for shipping, Veterinary Health Certificate, and crate (yours to keep). This is due when your puppy is 6 weeks old. If you are not shipping your puppy, the balance is \$_____.

3. Seller guarantees that puppy has received appropriate medical inoculations, worming and care. Seller warrants that the puppy you've purchased is in good health at the time Buyer assumes ownership. Buyer agrees to have the puppy examined by a licensed Veterinarian within two (2) days (not including weekends and holidays) of receipt of puppy/dog. Seller must be informed of the examination results immediately following the examination. Seller must also receive a copy of the examination by mail or email as soon as possible. Failure to do so will result in this contract being null and void.

4. If, as a result of the examination, the Veterinarian determines that the puppy is unfit for sale due to illness, or disease, the buyer may elect to return the puppy. Buyer shall, within 1 day of seeing a licensed Veterinarian, send to Seller by certified mail a written Veterinarian's certificate stating that the puppy was in ill health when examined. Upon receipt by Seller of said certificate, Buyer shall be obligated to return the puppy to Seller at Buyer's expense. Seller shall be obligated to replace the puppy with another puppy of the same sex and quality when one is available. Shipping costs and medical costs of the puppy are sole responsibility of the buyer, and further performance under this contract shall be null and void. All action taken to return the puppy shall be done with the best interest of the puppy in mind including temperature at time of shipment and non-stop flights. If the buyer chooses to keep the puppy, all medical costs will be at the buyer's expense and there will be no further guarantee by the Seller.

5. Check this box if you are choosing Loveland Bulldogs health guarantee. (stated below) If you are choosing the Paws Guarantee check here (you may only have one health guarantee) Your puppy is guaranteed to be free from fatal or life threatening genetic defects for 1 year from the date of purchase. Should the puppy be diagnosed with any genetically derived fatal or life threatening medical disorder which is confirmed by two unassociated veterinarians, the Buyer must send within 2 business days by certified mail written certificates by the veterinarians, of the disorder and prognosis of the puppy. Buyer will return puppy and be entitled to receive a replacement puppy of the same sex and equal value when one is available. If a replacement puppy is given the buyer is responsible for the shipping of the said puppy back to Seller and for the shipping cost of the replacement puppy- if any. If the Buyer chooses to keep the puppy, no replacement puppy will be given and all medical costs and treatment are sole responsibility of the Buyer.

6. The guarantee does NOT cover Cherry eye, glaucoma, retinal fold dysplasia, Entropion, Stenotic Nares, Elongated Soft Palate, Skin allergies, heat stroke, thyroid conditions, loose hips, and other common health issues that can arise in a French Bulldog. Buyer agrees that they have thoroughly researched the French Bulldog breed, and understand the many health issues they can possess. Buyer is aware that owning a puppy means trips to the veterinarian and understands that he/she will be responsible for all medical costs of their puppy. This guarantee covers only the original buyer and is not transferable.

7. Seller warrants that the puppy you have purchased is a purebred French Bulldog registerable with the American Kennel Club and that registration papers will be provided to the Buyer at the date of the completed purchase or shortly thereafter.

8. Buyer agrees that the puppy will reside at the home of the Buyer, have access to a fenced yard, not be chained or tethered, and will be provided with proper housing, a good quality diet, annual shots and exercise. Buyer agrees that at least one basic obedience training course will be completed with the puppy.

9. Buyer agrees that he/she is not acting as an agent in the purchase of this puppy and that Buyer will not sell this puppy or its progeny to any agent or pet store.

10.If (for whatever reason) the Buyer can not or does not wish to maintain custody of this puppy (at any time during it's lifetime) ownership shall revert back to it's Seller, including AKC papers and shipping costs.

11. Failure to abide by the terms of this contract will be considered as a breach of contract and this contract will be considered null and void.

12. In the event of breach of contract I, _____, do hereby agree that the breeders may obtain return of the puppy without any monetary reimbursement or obligation of the Breeders under this agreement. In the event that litigation is commenced to enforce the terms of this contract the breeders, being (Loveland Bulldogs), shall be entitled to the costs thereof; including, but not limited to, attorney fees, and all travel expenses incurred by them and their attorney.
